Does the audiometric testing service offer onsite testing at my place of business? Can they cover all my company locations?

What audiology support will I receive?

It is essential that the audiometric testing service you choose compares the audiograms to a baseline, to determine if hearing loss has occurred. This is vital to compliance with regulatory agencies and to maintain the health of your workforce. Audiological support isn't available when using a clinic and may be outsourced when renting an audiometer. Having audiological support not only helps interpret results, but also provides assistance with navigating OSHA standards.

Examinetics has a full-time team of expert audiologists who supervise all hearing conservation protocols, review threshold shifts, and help determine work-relatedness. Having a licensed audiologist available for questions and support protects you and your employees.

What reports will I receive? Does the audiometric testing service have a data management platform for record keeping?

You want to ensure you have timely reports so your teams can take immediate action. Confirm with your hearing testing partner that your employees will receive immediate notification of test results at the time of testing. In addition, work with a partner that will deliver a complete set of management reports for the onsite contact at the end of the test day.

Your company is responsible for maintaining records of all employees' audiometric results. To do this effectively, it is best if your audiometric data is stored in an online reporting database where you have access readily available.
