The steps to achieve Type 2 SOC 2 compliance for Examinetics took place during a 12-month period starting April 30, 2021, ensuring all essential controls are in place to protect client data.

Examinetics was specifically evaluated on security and privacy within their information technology systems. The **security** evaluation ensures systems are protected against unauthorized access, unauthorized disclosure of information, and damage to systems that could compromise the availability, integrity, confidentiality, and privacy of information. The **privacy** evaluation confirms that personal information is collected, used, retained, disclosed, and disposed of in accordance with the company's commitments.
