## Why Even Well-Intentioned Safety Programs Fall Short


Many companies take safety seriously. They provide safety training, respond to incidents, and have written policies. But good intentions alone won't prevent injuries, citations, or rising workers' compensation rates.


#### Reactive Safety Comes at a Cost

Waiting until something goes wrong leads to:

- Recordable incidents that could have been prevented
- Rush fixes that don't address root causes
- · Costly OSHA citations
- Higher insurance premiums and missed potential opportunities to bid on new projects
- EHS, HR, and operations leaders who are constantly in "firefighting" mode

- A Safety responsibilities spread across multiple roles with no clear ownership


These gaps might not be visible day to day, but they show up when it matters most during audits, injury claims, or contract reviews.




