Case Study: Injury Management Success at Bowen Engineering

Company Problem

Bowen Engineering, a nationally operating general contractor specializing in wastewater, energy, and chemical processing projects, faced significant financial and operational challenges due to workplace injuries. Even minor incidents had major cost implications with employees operating in physically demanding and safety-sensitive environments.

From 2013 to 2015, Bowen's workers' compensation premiums increased from **\$893,000 to over \$1.17 million**, driven by a rising Experience Modification Rate (EMR). As their EMR exceeded 1.1, Bowen became ineligible to bid on certain high-value projects, posing a critical threat to their revenue pipeline and industry reputation.

At the time, Bowen lacked a centralized, standardized injury management program. Each location handled incidents independently, often resulting in employees being sent offsite to a healthcare provider, even when the injury could have been resolved with basic first-aid. This default response not only disrupted operations but also frequently triggered unnecessary recordable cases under OSHA standards, inflating their TRIR and contributing to increased insurance costs.

Our Solution

Examinetics conducted a comprehensive evaluation of Bowen's injury management program. We reviewed three years of loss run data, OSHA 300 logs, incident reports, and insurance history. Our goal: redesign their program to reduce cost, minimize recordables, and restore competitive bidding eligibility.

We introduced a proactive, physician-led **Injury Management Program** tailored to Bowen's operational risks. The program integrated:

- 24/7 Tele-Triage access to licensed clinicians for immediate injury evaluation
- Case Management to guide appropriate care and recovery timelines
- Claims Administration to control costs and speed up processing
- Claims Investigation to uncover root causes and prevent recurrence

Implementation

Examinetics launched the new program with Bowen in **October 2016**. Our onboarding process included:

- Developing communication protocols and job profiles
- Training for supervisors on triage access and incident reporting
- Integrating our platform for streamlined documentation and analytics

- Their EMR decreased, making them eligible again for previously inaccessible bids
- The program helped them win **new contracts**, directly tied to their improved safety rating
